#### Categories of personal data processing

### Purpose and legal basis of processing and data retention

#### Nature of data provision and consequences of refusal of consent

### Scope of data communication and categories of recipient

The Data Controller, and the Joint Controllers, will not disclose the data, which will be communicated exclusively to internal personnel authorised to process it according to their respective duties, as well as to professionals, companies or other third parties that carry out outsourced activities and that are, therefore, appointed as data processors under the terms of a specific contract or other legal document.

## Transfer of data to a third country and/or international organisation

The personal data of the Data Subjects may be transferred, for the purposes for which it was collected, to a third party not belonging to the European Economic Area (EEA), that offer services related to the processing carried out by the Data Controller and described in this privacy policy or to which the transfer of data would be necessary as part of the execution of the service for the Data Subject.

The transfer of personal data to persons located outside EEA will take place solely by virtue of the execution by Data Controller and the non-EEA recipient of the standard contractual clauses adopted or approved by the European Union Commission (Commission implementing decision (EU) 2021/914 of 4 June 2021 and subsequence modification) or, alternatively, based on the decision of adequate of European Commission and/or other law instruments. If applicable the transfer of the personal data shall be based on the conditions of article 49 of the GDPR.

The Data Subject may obtain information about the transfer of her/his by sending a request to Data Controller as specified in the paragraph "Data Subjects' Rights" below.
